#### **SUBJECT**

Bid 33-22, Maintenance of Natural Gas Engines

#### BACKGROUND

EPWater has 25 stationary natural gas engines located at multiple wells and booster stations. These natural gas engines require scheduled maintenance service to keep all equipment in good operating condition.

The previous bid was opened on December 14, 2018. This bid is 3% higher than the previous bid.

# STRATEGIC OBJECTIVES SUPPORTED

Improve Efficiency

#### **EVALUATION PROCESS**

EPWater received one bid on May 3, 2022, from Southwest Commercial Engines, Inc. Staff evaluated the sole bidder and determined that Southwest Commercial Engines, Inc. met all the requirements as outlined within the bid proposal.

## FINANCIAL IMPLICATIONS

Sufficient funds are available in Account Number 420-7850, and the funding source is the Water and Sewer Fund.

## PROPOSED ACTION REQUESTED

Consider and award Bid Number 33-22, Maintenance of Natural Gas Engines, to Southwest Commercial Engines, Inc., the sole bidder, in the estimated annual amount of \$1,026,250 for a term of one year with the option for two one-year extensions, provided the funding is available in the approved budget.
