Payment for all associated excavation and for installation of the new 8-inch sewer main will be made at the stated unit price per linear foot for Bid Item No. 6 or 7 as specified, to include excavation, backfill, compacting, testing and any other requirements.

Any failure of the CONTRACTOR to complete the project within the contract time will be considered a material breach of this contract.
