

# WaterWise Business Rebate Program Commercial Water Customers Rebate Program Application

The El Paso Water's WaterWise Business Rebate Program offers up to \$15,000 to commercial water customers to purchase long-term water efficient equipment or to perform process upgrades.

# ELIGIBILITY

# Applicant:

- Must be a direct El Paso Water commercial customer with a record of service for at least the past twelve consecutive months from the date of application at current location
- Must be the business owner or manager with facility owner consent
- Must submit a fully completed application to El Paso Water for pre-approval before buying or installing any equipment
- Must include sufficient documentation to allow El Paso Water to verify the cost and annual water savings of the project
  - Current yearly water usage in gallons, estimated yearly water usage in gallons after project completion, and estimated total water savings
  - Savings calculations should be based on local, state, or nationally accepted studies including, but not limited to U.S. EPA WaterSense® and EnergyStar, U.S. DOE Federal Energy Management Program, American Water Works Association, Alliance for Water Efficiency, and Texas Water Development Board.
- Must be in compliance with current City of El Paso water restrictions, water efficiency standards, plumbing codes and equipment requirements
- Must agree to any needed pre- and post-installation in-person visits and photos by El Paso Water
- Must agree to cover full cost of project, if necessary, based on vendor payment rules
- Is responsible for meeting federal, state and city codes, and any regulatory and permit requirements
- Shall sign an agreement related to use of funds and acknowledgement of responsibilities to comply with terms of the rebate program

# Water Efficient Upgrades:

- Must provide documentation for water savings; projected water savings should be measurable and calculated based on an acceptable measured parameter
- Eligible equipment must achieve efficiency levels that meet or go beyond city code requirements
- EPWater rebate will not include labor, installation, consulting, taxes, or other nonequipment/material O&M costs
- Upgrades must have a design life of at least five years after installation

# **REBATE AMOUNT**

- Rebates will cover 50% of equipment or improvement cost or up to the maximum rebate amount
- A maximum combined rebate amount of \$15,000 is allowed per account, owner or management company per fiscal year (Based on equipment and material cost only. Installation and taxes not included).

## **CHECKLIST – PLEASE MARK**

□ Applicant meets all eligibility requirements listed on page 1

- □ Applicant acknowledges that application must be submitted for approval **before purchasing or installing any equipment** and must include:
  - □ A detailed description/conceptual design of the project, including water savings calculations, design life of equipment and a project timeline.
  - □ A detailed manufacturer/vendor quote itemizing equipment and material costs, installation, etc. EPWater rebate will only cover equipment and material costs.

## **APPLICATION PROCESS**

- Applications will be accepted until funds are exhausted, so don't delay and **apply today!**
- EPWater staff will review applications.
- Any incomplete applications, missing water saving information, quotes, etc., will be denied.
- Any projects with questionable yearly water savings will be reviewed with customer for accuracy.
- Proposed projects resulting in the highest verifiable amount of yearly water savings will be given priority.
- EPWater staff will contact businesses to schedule a pre-installation visit to photograph current equipment or processes.
- Businesses with approved applications will receive a letter of intent, a W-9 form to be completed and a memorandum of agreement from El Paso Water to begin proposed projects after the pre-installation visit is complete and agreement is executed. DO NOT BEGIN ANY WORK UNTIL RECEIPT OF EPWATER LETTER OF APPROVAL AND MEMORANDUM OF AGREEMENT HAS BEEN EXECUTED BY BOTH EL PASO WATER AND BUSINESS OWNER AND/ OR LANDLORD.
- Business will have **four months** from the date of memorandum of agreement to complete projects. Extensions to complete work may be granted upon approval.
- Business will submit to El Paso Water itemized, paid-in-full receipts with vendor contact and payment information upon project completion.
- EPWater staff will contact Business to schedule a **post-installation visit** to photograph new equipment or processes.
- Allow 6 to 8 weeks to receive rebate check from El Paso Water.
- Business must report actual water savings resulting from the project to EPWater after the first year post-installation. If the report is not received, recipient may be ineligible for future rebates.
