SUBJECT

Sole Source Contract with Thatcher Company of Arizona, Inc. (Thatcher)

BACKGROUND

EPWater completed the Corrosion Control Study (CCST) as stipulated by the Texas Commission on Environmental Quality (TCEQ) to determine the optimal water quality parameters required to ensure the safety of our water supply. The bench study was conducted by Carollo Engineers, Inc. using the 50/50 blend of TI-2904 poly/orthophosphate currently in use by EPWater for corrosion control to prevent damage to infrastructure. Based on this study, TCEQ has set the required optimal water quality parameters in which they specify the use of the TI-2904 blended poly/orthophosphate. Thatcher is the sole provider of TI-2904 poly/orthophosphate.

PRIOR PSB ACTION

• On July 13, 2022, the Public Service Board approved a sole source contract with Thatcher Company, Inc. for the supply of TI-2904 poly/orthophosphate used in EPWater's corrosion control program.

UTILITY KPI ALIGNMENT

Infrastructure Performance

EVALUATION PROCESS

Staff evaluated Thatcher's proposal and determined that it meets all the requirements of the utility. Thatcher is the sole source TI-2904 poly/orthophosphate formulation pursuant to Section 252.022(a)(7)(A) of the Texas Local Government Code.

FINANCIAL IMPLICATIONS

Sufficient funds are available in Account Number 7500, and the funding source is the Water and Sewer Fund. This expenditure is part of the FY2025-26 budget.

PROPOSED ACTION REQUESTED


Consider and approve a sole source contract in accordance with Section 252.022(a)(7)(A) of the Texas Local Government Code with Thatcher Company of Arizona, Inc. for the supply of the TI-2904 poly/orthophosphate blend to EPWater in the estimated annual amount of \$2,000,000 for a one-year term with the option for four one-year extensions contingent upon the vendor providing annual documentation attesting to their sole source status.
