## **SUBJECT**

Consider and Approve a Master Contract with HD Supply Facilities Maintenance, Ltd. dba USABlueBook (USABlueBook)

#### **BACKGROUND**

USABlueBook provides specialized products and materials used throughout EPWater operations and maintenance. These include critical items for laboratory testing, water quality monitoring, safety compliance, and general facility support across EPWater. Products, services, and equipment provided by USABlueBook support compliance with regulatory requirements and maintain the operational integrity of critical water and wastewater infrastructure.

### **EVALUATION PROCESS**

Staff evaluated the USABlueBook cooperative contract through OMNIA Maricopa County, AZ Contract Number 16154 and determined that the vendor meets the operational and maintenance needs of EPWater for this type of procurement. USABlueBook has historically provided high-quality goods and services and has consistently demonstrated reliability, responsiveness, and professional qualifications.


