SUBJECT

Engineering Selection for On-Call Professional Engineering Services for Stormwater and Wastewater Lift Stations – RFQ 52-25

BACKGROUND

EPWater operates and maintains over 75 stormwater and wastewater lift stations. These stations require continuous design and rehabilitation for pumps, motors, structural, electrical, mechanical, and HVAC systems. EPWater requires on-call professional engineering contracts providing design, construction-phase, and technical services on an as-needed basis to maintain reliability and address emergency or planned improvements.

The new contracts will ensure continuity of engineering support for EPWater's lift-station infrastructure and provide flexibility to issue task orders as projects arise across the capital improvement and operational programs.

PRIOR PSB ACTION

• On January 11, 2023, the Public Service Board approved RFQ 108-22, On-Call Professional Engineering Services for Stormwater and Wastewater Lift Stations, awarding five contracts for a three-year term.

EVALUATION PROCESS

EPWater received 17 Statements of Qualifications in response to Request for Qualifications RFQ52-25. The shortlisting committee evaluated the proposals and shortlisted to 10 firms.

On November 19, 2025, the Architectural/Engineering (AE) Selection Advisory Committee convened to review the submittals. The committee who scored the SOQs consisted of Bryan Morris, Charlie Intebi, Gilbert Trejo, Irazema Rojas, Gisela Dagnino, Martin Noriega, Felipe Lopez, and Jeff Tepsick. Each SOQ was evaluated based on minimum qualifications, firm profile, proposed project team and experience, and past project performance

Following a comprehensive review, the committee selected the following six firms based on their qualifications, capacity, and demonstrated experience. The recommendation is to award a contract to each of the following highest qualified firms: AECOM Technical Services, Inc, Arcadis U.S., Inc., Brown and Caldwell, CEA Engineering Group, Inc, Garver, LLC, and Moreno Cardenas, Inc.

FINANCIAL IMPLICATIONS

Sufficient funds are available in various accounts. This expenditure is part of the FY2025-26 budget.

PROPOSED ACTION REQUESTED

Consider and award a professional engineering services contract for On-Call Professional Engineering Services for Stormwater and Wastewater Lift Stations – RFQ 52-25 to AECOM Technical Services, Inc, Arcadis U.S., Inc., Brown and Caldwell, CEA Engineering Group, Inc, Garver, LLC, and Moreno Cardenas, Inc., for an amount not to exceed \$1,500,000 for each firm, with a contract term of three years each.
